Tenders must be accompanied by earnest money deposit which should be paid online through e-Procurement portal using any of the following payment modes: Credit Card, Direct Debit, National Electronic Fund Transfer (NEFT), Over the Counter (OTC). Tenders must be electronically submitted (on-line through internet) with in the date and time published in e-procurement portal. Eligibility criteria:

1. Any reputed Individual / Company registered with BBMP / CPWD / KPWD / Railways / MES or any State Government Organizations are eligible to apply.
2. No Joint Venture / Consortium is permissible.
3. The Tenderer shall have executed and completed successfully in any one financial year during block period of previous five financial years. i.e. between 2008 – 2009 and 2013 – 2014 a single work of similar nature of value not less than 50% value of amount put to tender In support of this, the Tenderer shall furnish a Work Completion Certificate duly certified by the Competent Authority not below the Rank of Executive Engineer shall be uploaded along with Technical Bid. The Work Completion Certificate shall mention the Nature of Work, Items of Work executed and the Date of Commencement and Date of Completion of the Work.
4. Tenderer shall furnish list of technical staff required for the work (Organisation chart).and Equipment and Machineries possessed by him / her.
5. Present net worth not less than 75% of amount put to tender.
6. Should own at least 50% of the required key machineries /equipments for the work. Proof of ownership should be enclosed. Remaining 50% can be deployed on lease or hire basis, Proof for hire or lease agreement should be enclosed.
7. Achieved at least two financial years a minimum financial turnover not less then amount put to tender in all civil Engineering works in last 5 years.
8. Latest income tax paid certificate (Challan) from the income tax department.
9. The successful tenderer will have to execute agreement as present with BBMP within seven days of receipt of intimation,
10. The Bruhat Bangalore Mahanagara Palike reserves the right to accept / reject any or all the tenders without assigning any reasons.
11. The validity of tender is 3 months from the date of opening of tender.
12. The work should be commenced with all men and machinery within seven days from the date of work order, failing which it would be presumed that he is not interested in his work and action will be taken to get the work executed through alternate agency at the risk and cost of the former tenderer.
13. After opening of the tenders, before signing of the agreement, tenderer shall be asked to give a Demand Draft/Bank Guarantee for difference of amount between the quoted rates and the estimated cost, if the rates quoted are less than the estimated cost.
14. Conditional tenders will not be accepted.
