The Contractors may submit tenders for any or all of the works given in the table in appropriate class registered in Bruhat Bangaluru Mahanagara Palike /CPWD /KPWD /Railways /MES / any State or Central Govt. organization.

The tender can be downloaded in the portal as per prescribed date and time published in the portal. Only Interested Contractors who wish to participate should remit on line transaction fee for tender after registering in the portal. If you wish to participate The transaction fee is non-refundable
- 4 Tenders must be accompanied by earnest money deposit as well as Tender Processing Fee which should be paid online through e-Procurement portal using any of the following payment modes: Credit Card, Direct Debit, National Electronic Fund Transfer (NEFT), Over the Counter (OTC).
- 5 Tenders must be electronically submitted (on-line through internet) within the date and time published in e-procurement portal. Tenders will be opened at prescribed time and date in the e-procurement portal , in the presence of the Tenderers who wish to attend at the OFFICE OF THE EXECUTIVE ENGINEER, Dasarahalli Division, Hesaraghatta main Road, Bangalore.73

### **TERMS AND CONDITIONS**

- 1 Conditional tenders will not be accepted
- 2 The contractor has to make own arrangements for procurement of all materials. There is no departmental supply of materials. Contractor should procure materials with BIS or other relevant standards & obtain necessary quality control certificates from authorized quality control authority.
- 3 **The contractor is not eligible for submission of application for tender form if he has not participated in tenders after purchase of the tender document continuously for three times.**
- 4 Sub-letting of work is prohibited
- 5 Further Any corrigendum/Modification will be notified in the Notice Board of the undersigned.
- 6 As per Govt order No. LD/300/LET/2006.Dated: 18.01.2007 and Addl, Commissioner (Finance) No. BBMP/CAO/PR/06/07-08 dated: 03.08.07 the Building Construction Laborers Welfare Cess (1% of Estimated cost) will be deducted from contractor bills.
- 7 Necessary taxes and other deductions will be made from contractor bills
- 8 The successful bidder will have to execute an agreement with BBMP within 7 days of receipt of intimation, failing which his tender is liable to be rejected.
- 9 The Bruhat Bangalore Mahanagara Palike reserves the right to accept/reject any or the entire tender's without assigning any reasons.

- 10 The tenderers should have to produce contractors registration book issued by the concerned authority for procurement of tender documents. Applicant should submit Proof of registration, latest Income Tax Clearance Certificate, obtained from the Concerned Department while submitting the request for application for the Tender Schedules, otherwise the application will be rejected.
- 11 The Work should be commenced with all earnestness within 7 days from the date of Work Order, failing which it would be presumed that he is not interested in the work and action will be taken to get the work executed through alternate agency at the risk and cost of the former Tender.
- 12 If the rate/amount quoted by the tenderer is less than the rate/amount of the Tender amount , such tenderer while submitting by the time of agreement shall remit the **difference amount in form of DD in favor of The Commissioner, Bruhat Bangalore Mahanagar palike along with separate EMD amount.** This difference amount will be returned after satisfactory completion of the work only. Failure to comply with the said conditions, the tender will be rejected.
- 13 As Per Standard Tender Document-KW-1 & KW-2 The Successful Tenderer Shall Deliver to the Employer **as Security deposit in form of DD in favor of the Commissioner, BBMP A/C Executive Engineer (Dasarahalli Division)**
- 14 **The Bidder should Satisfy the Financial Capacity as per Standard Tender Document KW-1 & KW-2 Otherwise Their Requisition is Rejected.**
- 15 Validity of Tender 90 days from the date of opening of the tender.
- 16 Certified xerox copy of the valid Registration Certificate issued by the Bruhat Bangalore Mahanagara Palike for the block period of 2010-2015 should be enclosed with the tender documents.
- 17 The contractors who own plants and machinery required for the work only need apply for chip carpeting and asphaltting works.
- 18 For Asphaltting works that is Bituminous macadam and asphaltting concrete those who own their hot mix plant and Mechanical paver only shall apply.
- 19 **The Tender Accepting Authority shall have the power to accept or reject any tender without assigning any reason thereof.**
- 20 The Income Tax, VAT, Royalty, CBF, and BWFF etc., Cess will be Deducted and certificate will be issued in favor of the Contractor from every running bill / final bills of the contractor.
- 21 The rates quoted in the schedule shall be inclusive of all taxes applicable.
- 22 The work shall be carried out as per the directions of the BBMP Engineer in-charge Of the Work.
- 23 The successful Tenderer shall execute an Agreement within 7 days from the date of receipt of the intimation from this Office, failing which the Tender will deem to be get cancelled.
- 24 The Bidder should produce all the original documents for verification whenever necessary.
- 25 Any other details regarding the works & other information can be obtained from the above office during office hours.
