- 2. For Sl.No 07 Work Manufacturers should have a minimum similar nature of work executed experience costing 50 % of estimated cost and minimum Turnover of 2times the above work.
- 3. No Joint Venture / Consortium are permissible.
- 4. The Tenderer shall have executed and completed successfully in the last Three years i.e. between 2009–2010 and 2011–2012 a single work of similar nature of value not less than 50% of estimated value of Contract. In support of this, the Tenderer shall furnish a Work Completion Certificate duly certified by the Competent Authority.(Preference will be given to the tenderer work done in BBMP)
- 5. The Tenderer Should not incurred any loss in more than a year during the last 3 years ending 31st March 2012 i.e. between 2009–2010 and 2011–2012. For reference submit Three years Audited statements duly sighed by Charted Accountant (Three Forms) and the Annual returns filed to be furnished through portal.
- 6. Shall have minimum Annual turnover not less than two times the amount put to tender during one of the last three financial years. i.e. between 2009–2010 and 2011–2012 certificate certifying the turnover from Charted Accountant to be furnished through portal
- 7. Tenderer should submit their EMD and tender processing fee in the form of e-payment through e-Procurement Portal (Credit Card, Direct Debit, National Electronic Fund Transfer (NEFT), and Over the Counter (OTC).
- 8. Bidders/Contractors can access tender documents on the website, fill them and submit the completed tender document into electronic tender on the website https://eproc.karnataka.gov.in/.
- 9. The tenderer is required to ensure browser compatibility of the computer well in advance to the last date and time for receipt of tenders. The departments shall not be responsible for non-accessibility of e-Procurement portal due to internet connectivity issues and technical glitches.
- 10. Non submission of the tender attracts action as per conditions stipulated in the rules of registration of Contractors.
